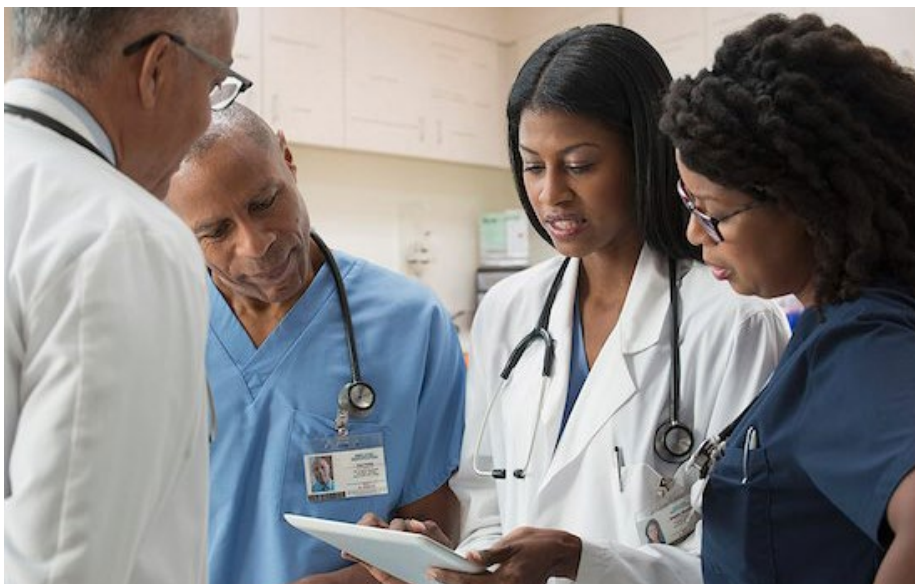

# Don't Miss Opportunity to Review New Changes



Florida SHOTS is always looking for ways to improve its functionality and effectiveness. As part of that ongoing effort, Florida SHOTS likes to make sure its users are up-to-date on the latest registry updates.

Finding out what's new with the latest version of the registry is easy. When you head to the Florida SHOTS login screen, click on the "Current Announcements" link at the bottom of the page. You will then be able to view the latest new release changes to the system, which cover important updates and corrections.

One such correction involves the DTaP vaccine series. Prior to the latest Florida SHOTS release, the system was suggesting a four-dose series was required for patients who received their first DTaP shot after age 7. That schedule has been corrected to recommend a three-dose series for patients starting the series after age 7. Also, the latest release raises the recommended age for receiving the Meningococcal B vaccine from 10 to 16 years of age.

Florida SHOTS users should also be aware of updates to the functionality of DH Form

680. Patient DTaP status will now no longer prevent the production and certification of the form Part A1 as long as the patient only has the 7th grade requirement of a single Tdap dose left to complete. Additionally, users can now produce a fully generated 680 form rather than a blank form in cases where a patient doesn't meet the requirements for the type of form selected. (Note: If a form does not meet all of the requirements for the form part selected, it cannot be certified in Florida SHOTS; rather it must be printed and signed by hand.)

These are just a few of the important changes Florida SHOTS users will learn about in the "Current Announcements" section of the Florida SHOTS login screen. ### What do you think is the best feature of the registry for your office?

We also find that the new data loggers are especially helpful in managing our unit temperature records. It allows us to upload temperatures quickly, easily, and seamlessly and supplies us with ready access to current and active records management.

### What do you think is the best feature of the registry for your patients?

By entering patient vaccine information into the Florida SHOTS registry, multiple users will have complete and transparent access to a patient's vaccination records anytime, anywhere. Once the data is entered into the system, users have the ability to retrieve and print out a complete immunization record on-demand. This is a great feature!

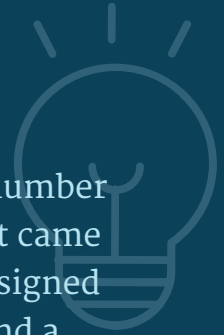


# Did You Know?

The CDC recommends that pregnant women get a flu shot during any trimester of their pregnancy to protect themselves and their newborn babies from flu. Also, moms-to-be can give their babies protection against potentially deadly pertussis by getting the Tdap vaccine during the third trimester of pregnancy.

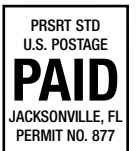
# 275 MILLION+ SHOTS

## ACCURATE DATA CONNECTIONS ARE ONE OF A KIND

### Minimize duplicates to maximize efficiency.

Duplicate patient records take time, effort, and resources to correct, but there are simple steps you can take to minimize duplicates. When you search for a patient, if multiple patient records come up, hover over the names to see the patient's address and current immunization provider (CIP). Select the record that matches your patient's information. Enter and confirm as much personal information about a patient as possible (e.g., parent names and address). Release the record as soon as you're finished. Additionally, if you have a real-time data upload connection from your EHR/EMR to the Registry, try to avoid entering data manually.

If you discover a duplicate patient record, call the Florida SHOTS Help Desk to fix it. Never try to manipulate record information to force records to merge, since it's very difficult to re-separate records once they are incorrectly merged.
