Check Immunization Status at Every Visit



Over the past year, you may have noticed new enhancements to help Florida SHOTS better align with Advisory Committee on Immunization Practices (ACIP) recommendations now and in the future. One noticeable change is that the "Immunization Status" page has been divided into the patient's status for each recommended antigen, with the option to display "Not Started" antigens and possible dates.

The "Immunization Status" page helps users by simplifying the ACIP schedules for patients of all ages. Based on the patient's age, immunization history, and any recorded observations, the system forecasts all the possible vaccines—both required and recommended—that the patient may receive. Users will see the minimum and recommended dates for administration. We have already updated the registry algorithms with the latest 2019 ACIP pediatric and adult immunization schedules, and you can download them here: www.cdc.gov/vaccines/schedules/ hcp/index.html

Remember to use every patient encounter as an opportunity to check the Florida SHOTS "Immunization Status" page, to see all possible vaccines that may be due or overdue and keep your patients on track!

Vou Said It



What is your name, the name of your office, and your title?

My name is Penny Varner, I work for St Joseph's Children's Hospital Mobile Clinic. I am an APRN and the clinical coordinator.

What do you think is the best feature of the registry for your office?

We have recently transitioned to a new EMR system that is compatible with Florida SHOTS. The ability to have the immunizations we provide cross over to the registry is much more efficient than manually entering vaccines.

What do you think is the best feature of the registry for your patients?

Many of our patients are new to the area and will only see us until they have insurance and a medical home in Tampa.

Since all of their immunization records are consolidated in one place, it makes that transition much easier.

How have you implemented Florida SHOTS into your daily workflow?

We have utilized Florida SHOTS since the beginning of our program and it is firmly integrated in our process. We use the Immunization Status feature to ensure that we take advantage of the opportunity to provide every vaccine that is due during the child's mobile clinic visit. Our discharge plan with the family includes using the Vaccine History feature to help the family see when the next vaccine will be due for each of their children, and the Reminder/Recall feature allows us to contact parents to remind them when their child is due for follow-up vaccines. It's always nice to know what others who are enrolled in Florida SHOTS have to say about the program. In each issue, we share what some of our top users think about the registry. This interview features **Penny Varner, APRN, Mobile Clinic Coordinator** for St. Joseph's Children's Wellness and Safety Center.

If another doctor's office were to call and ask you why they should enroll in the registry, what would you say?

Florida SHOTS is a great tool to assist you in managing the immunization needs of your patients. Tools like the Reminder/ Recall feature help us ensure our families are aware when their children are due for follow-up vaccines. The Vaccine Utilization tool is helpful in predicting future needs based on past usage.

Is there any other information you would like to share about your experience with Florida SHOTS?

We have found the database very user friendly and the customer support outstanding. I can't imagine running our clinic without it.

Now Is the Time for Real-Time Uploads

DATA UPLOAD

By July 1, 2019, all data uploads will be moving to real-time web services. With web services, uploads occur automatically, so as soon as Florida SHOTS receives the records from your electronic health record (EHR), the shots are processed immediately! This means your office can instantly create and print the DH Form 680 and immunization history forms without duplicate data entry.

If your office is currently using a "batch" process to upload your immunizations, make sure to contact your software provider to ask about real-time and bi-directional web services, as Florida SHOTS will **no longer accept batch files after June 30, 2019**. Your EHR company will need to move to real-time web services for your shots to upload and post.

As we move through the process of converting all uploads to web services, our Florida SHOTS Data Team will be working closely with practices to ensure a smooth transition.



Coming Soon: Vaccines for Children (VFC) Inventory Enhancements!

In the coming months, VFC providers will have several improvements to entering shots, inventory tracking, and simplified ordering! Offices that manually enter shots will be able to easily add VFC vaccines by selecting from a dropdown menu, and inventory will automatically decrease as shots are administered. The VFC Program will provide more details about when each office will receive these enhancements in Florida SHOTS. Stay tuned!

Tech Tips

As a Local Organization Administrator (LOA) what do I need to do if an employee and authorized Florida SHOTS user leaves our practice?

LOAs are responsible for maintaining an accurate and current Personnel List, including adding new users and unlocking passwords. They're also responsible for making sure that only authorized users have access to Florida SHOTS—including removing personnel who leave the practice. This can be done by opening personnel records and entering an "end date" to remove former employee access to the registry through your organization.

IT'S BETTER TO CATCH AN ERORR EARLY THAN FIND IT LATER.

CHECK NOW. SAVE TIME LATER.

A simple data entry mistake can cause numerous errors including duplicate records, inventory discrepancies and invalid shots. Prevent these problems by double-checking your data entry for mistakes before you hit SUBMIT.

Real-time data exchange allows for instant reporting and tracking of shot data. It eliminates double data entry—reducing the chance for errors. As of June 30, 2019, all providers will need to be using real-time interfaces.

If you aren't already using a real-time interface, check with your software provider about switching to real-time data exchange. Transition times can take months—act now!
