Give Parents Access to Their Child's 680 Form

As the school year comes to a close and the summer rush sets in, your office will administer more vaccines and certify numerous DH Form 680s. Creating electronically certified (e-certified) forms within Florida SHOTS can be a huge timesaver for you and your patients. By e-certifying the forms, you not only save a copy that is accessible to schools and child care providers, but you can create a Parent PIN that allows a parent/guardian to print it from home.


Parents/guardians are able to access the certified Form 680 by entering the Certification PIN and State IMM ID found on the information sheet that your office provides from Florida SHOTS. A PDF version of the form allows it to be printed or saved for easy access! Data Upload Spotlight

DATA UPLOAD

Free, Expert Help with Data Quality

If your office participates in data exchange through your Electronic Health Records (EHR), it’s important to regularly monitor and ensure that your data is uploaded as timely and accurately as possible. Don’t know where to begin to check for errors and warnings? We’re here to help!

Every month we offer Data Quality Webinars to help your office verify that your vaccine records are uploading properly into Florida SHOTS. Our Data Upload Specialist provides step-by-step training for running customized reports to review and troubleshoot your uploads.

Providers—especially Vaccines for Children (VFC) participants—can benefit from getting answers to common questions about inventory reconciliation, successful data upload and processing, and preventing errors in the first place!

Upload Tip:

Many data elements are required to be reported, per Florida Department of Health, Emergency Rule 64DER20-43.

Your Florida SHOTS account will automatically deactivate if you do not login regularly. If your account becomes deactivated, please contact your Local Organization Administrator (LOA) for assistance. Contact our Helpdesk at **(877) 888-7468** if you need confirmation of your LOA.

Tech Tips



“As a Local Organization Administrator (LOA), what do I need to do if an employee and Florida SHOTS user leaves our practice?”

LOAs are responsible for maintaining an accurate and current personnel list, including adding new users and unlocking passwords. They’re also responsible for making sure that only authorized users have access to Florida SHOTS—including removing personnel who leave the practice. This can be done by opening personnel records and entering an “end date” to remove former employee access to the registry through your organization. 
529 MILLION+ SHOT RECORDS

As of May 1, 2023, we've processed more than 529 million shot records via data upload from over 15,000 participating health care providers and multiple insurance organizations. There are also 2,993 real-time live web service health care provider connections through 145 EHRs.
