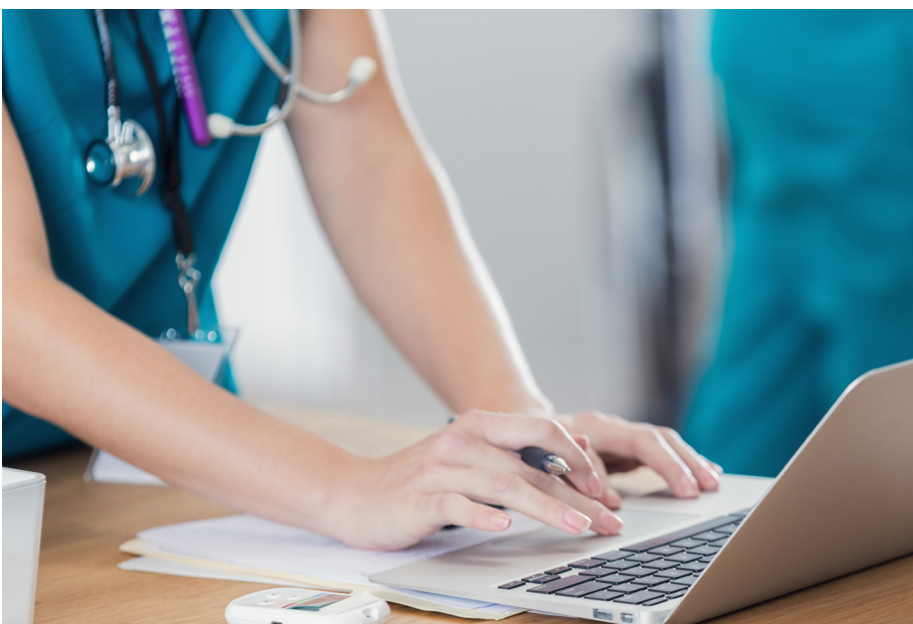

Using Florida SHOTS: Easy As 1-2-3



This year we're preparing for an increase in Florida SHOTS participation due to recent legislation requiring healthcare providers who administer vaccines to patients from birth through age 17 to report vaccinations to Florida SHOTS, unless the parent or guardian has opted out. This legislation also requires college health centers administering vaccinations to students 18 through 23 to report vaccinations to Florida SHOTS, unless the student has opted out.

This requirement goes into effect January 1, 2021.

We have numerous resources to get providers enrolled and up and running with Florida SHOTS and data exchange. To get started, it's as easy as 1-2-3!

- 1. Enroll:** Visit flshotsusers.com and click "Apply online" in the "Enroll Today" box.
- 2. Train:** Learn how to use our tools and features—at your pace and on your schedule. Visit flshotsusers.com/training.
- 3. Upload:** Data upload allows practices to automatically update shot records from their existing medical software. Learn more at flshotsusers.com/data-exchange.

Also, whether your office is new to the program or needs a refresher, we host a regular "[New User/Refresher Training](#)" on the fourth Tuesday of every month. We're here to help you get the most out of Florida SHOTS!

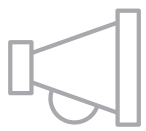

What do you think is the best feature of Florida SHOTS for your office?

The bidirectional upload and the immunization history are two of our favorite features at FCHC.

The bidirectional upload affords us a much more seamless process when reviewing and printing the 680 forms. Access to Florida SHOTS saves time for our staff since we no longer have to handwrite the forms.

If another doctors' office were to call and ask you why they should enroll, what would you say?

We are proud to be able to partner with Florida SHOTS to provide immunizations to our patients. The ability to access the system to obtain accurate and current immunization status on our patients is a tremendous benefit to our staff and our patients. We are able to ensure that our patients are current with their immunization status with a streamlined process. Utilizing

Florida SHOTS aligns with the FCHC vision of fostering and promoting collaborative relationships and developing partnerships to enhance the quality of delivery systems for comprehensive healthcare.

How have you implemented Florida Shots into your daily workflow?

FCHC clinical staff use the system on a daily basis. We use Florida SHOTS as part of our huddle process to determine the vaccination status on all patients coming in for an appointment. This assists us to quickly understand what vaccines may be due or missing, and helps us to quickly determine flu shot status. Incorporating the system into our daily workflow allows us to do our best in ensuring our patients are up-to-date on vaccinations. It also allows us to make every visit an opportunity for immunization, as we access the site for every visit for every patient and can catch up if necessary.

Now Is the Time for Real-Time Uploads

DATA UPLOAD

Here at Florida SHOTS, we love to hear feedback from practices participating in data upload. We spoke with Alix Casler, M.D., F.A.A.P., Chief of Pediatrics for Orlando Health Physician Associates, a multi-office primary care pediatric department in Orange, Osceola, Seminole, Lake, Volusia, and Polk Counties, about her practice's experience with data exchange through their EHR software Allscripts.



What do you think is the best feature of Florida SHOTS for your patients?

Patients vaccinated here in the state of Florida can be confident that their vaccine data will be available to all providers so that they need not maintain the information themselves. This also means that patients may be kept up-to-date on their vaccines easily, and this minimizes the incidence of unnecessary revaccination due to lack of information.

What were the primary reasons you chose to participate in the data upload?

We embrace technology as it contributes to better care of our patients. Having their vaccine histories readily available to all providers means that our patients are more likely to be up-to-date and well-protected. It also makes it much easier for them to have their vaccine records readily available whenever needed. Coincidentally, it makes life easier for us and our staff, as we rarely have to go searching and requesting records from elsewhere.

How has your experience with the data uploading from your EHR to Florida SHOTS been?

Generally, it is effortless with real-time uploads. We are working on a bidirectional interface that will make our experiences even easier and more streamlined—looking forward to that!

Did You Know?

Coming Soon: Vaccines for Children (VFC) Inventory Enhancements!

In the coming months, VFC providers will have several improvements to entering shots, inventory tracking, and simplified ordering! Offices that manually enter shots will be able to easily add VFC vaccines by selecting from a drop-down menu, and inventory will automatically decrease as shots are administered. Stay tuned!

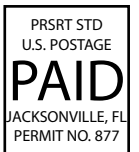

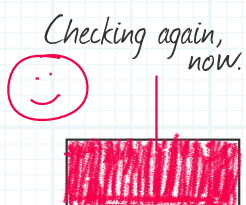
