

# VFC Inventory Updates: “Shots Recorded” FAQs



Florida SHOTS displays the Shots Recorded in the **“VFC Order Request: Inventory Levels”** page. The **“Shots Recorded”** numbers can be used to discover any differences between the VFC vaccine that you have counted within your records (Doses Administered) and what your office has recorded in Florida SHOTS (**Shots Recorded**). Moving forward, this feature will help streamline your ordering process.

If you see any differences between the two numbers, there are several steps that you can take to determine the cause and make any corrections. This should prevent the problem in the future.

## 1. HOW ARE THE “SHOTS RECORDED” COUNTED?

Florida SHOTS tallies all of your vaccines that are entered via data upload or manually through the **“Add Vaccination”** screen by matching VFC eligibility, vaccine lot numbers, manufacturer and expiration dates.

## 2. WHAT IF MY “SHOTS RECORDED” AND MY “DOSES ADMINISTERED” DON’T MATCH?

There are several factors that will cause a discrepancy such as the incorrect lot number/expiration date entered, Funding Program not selected in the patient record, etc. But, please note that one of the easiest ways to prevent calculation errors is being sure that that you enter vaccine details accurately.

For example, in the inventory below (Figure 1), you see the new column and row showing **“Shots Recorded.”** This example organization has 0 doses of the VFC inventory recorded, but 5 doses of “other” Daptacel vaccine that are shown as recorded. If you look closely, you can see that the lot numbers are very similar and appear to be a data entry error. Check the lot numbers entered into your records to see if the lot number was incorrectly recorded. Correcting the vaccine information in the affected patient records will allow Florida SHOTS to count those doses as recorded.

A **“Shots Recorded Report”** can be generated to view all of the VFC vaccines entered and/or uploaded for a specific time period. The report also displays whether there’s an inventory match to assist in identifying any discrepancies.

### 3. WHAT SHOULD I DO IF MY “SHOTS RECORDED” ARE ZERO?

If there are no shots recorded for your organization, this means that your VFC site has either NOT properly entered (or uploaded through your EHR) your administered doses into patient records, OR VFC eligibility was not provided for vaccines administered to that patient. Remember, it is a program requirement to enter VFC eligibility for all VFC vaccines. We suggest that you run a “**Vaccine Utilization Report**” to view all of the details for vaccines entered and/or uploaded for a specific time period.

For offices participating in data upload, you can also check your “**System Transactions**” to be sure that your EHR is uploading these vaccinations correctly and with all of the VFC eligibility criteria. ### 4. WHY ARE MY PRIVATE VACCINES BEING COUNTED ON MY VFC ORDER?

If you click on the blue hyperlinked total number of shots recorded, you will pull up a detailed list (**Figure 2**) of the vaccines recorded by vaccine type and patient name since your last order. This will also display the VFC eligibility of each recorded vaccine.

If you see “**Privately Insured,**” on your list, it means that VFC vaccine was recorded as being given to patients with private insurance. In most cases, this is a data entry error that can be corrected after the fact, and prevented by properly entering the eligibility criteria. One easy way to prevent calculation errors is to make sure that when you enter privately purchased vaccines, do **NOT** select a “**Funding Program**” from the drop-down list. Leave the field as “**-Select-**” (**Figure 3**).

**5. WE HAVE BEEN ENTERING THE CORRECT LOT NUMBERS FROM THE VACCINE BOX, BUT FLORIDA SHOTS HAS SOME LISTED INCORRECTLY ON OUR “ORDER REQUEST INVENTORY” LIST. HOW CAN WE CORRECT WHAT IS LISTED ON FLORIDA SHOTS?**

At this time, it isn’t possible to correct VFC lot numbers and expiration dates after they have been accepted through “**Pending Receipts.**” As you can see, now it is even more important to carefully check your VFC shipments against your “**Pending Receipt**” list in Florida SHOTS. You have the option to revise the pending receipt to correct any errors (**Figure 4**) before you accept the vaccines into your inventory and prevent these errors in the future. If you see that the lot numbers/expiration dates on the package differ from those on the vaccines inside, please call a VFC representative at 1-877-888-7468 to assist you.
