The first row displays organization grand totals for vaccine inventory within each site.

- First row, column B displays totals from beginning inventory.
- First row, column C displays total inventory received into the organization and each site.
- First row, column D displays total number of doses administered.
- First row, column E/F displays the net total of transferred inventory between sites.
- First row, column G displays if there are any imprecise measurements or auto-incremented inventory.
- First row, column H displays the vaccines that are considered "Waste."
- First row, column I displays the vaccines that are considered "Spoiled."
- First row, column J displays the vaccines that are considered "Expired."
- First row, column K/L displays the allowed adjustments.
- First row, column M displays the total net doses that are considered "Unaccounted For."
- First row, column N displays the total net percentage that is considered **"Unaccounted for"** from column M divided by columns B+C+F+G.
- First row, column O displays the total net cost of the **"Unaccounted for"** vaccines according to the Vaccine Pricing Table.
- First row, column P displays the absolute total of vaccines that are considered "Unaccounted for."
- First row, column Q displays the Absolute percentage of vaccines that are considered **"Unaccounted for"** for column P divided by columns B+C+F+G.
- First row, column R displays the absolute total cost of the **"Unaccounted for"** vaccines according to the Vaccine Pricing Table.
- First row, column S displays the calculated inventory on hand by adding columns B+C+D+F+G+T+L+M.
- First row, column T displays the number of doses that are considered **"Wasted, Spoiled, and Expired vaccines."**
- First row, column U displays the percentage of doses that are considered **"Wasted, Spoiled, and Expired vaccines"** by calculating columns H+I+J divided by B+C+F+G.
- First row, column V displays the total cost of the **"Wasted, Spoiled, and Expired vaccines"** according to the Vaccine Pricing Table.

- Site row, vaccine type, column C displays the lot number.
- Site row, vaccine type, column D displays the expiration date.
- Site row, vaccine type, column E displays the beginning inventory balance.
- Site row, vaccine type, column F displays the number of doses received into the site's inventory.
- Site row, vaccine type, column G displays the number of doses administered by the site.
- Site row, vaccine type, column H/I displays the total net transfers done by the site.
- Site row, vaccine type, column J displays the number of imprecise measurements and auto increments.
- Site row, vaccine type, column K displays the number of doses considered as "Waste."
- Site row, vaccine type, column L displays the number of doses considered as "Spoiled."
- Site row, vaccine type, column M displays the number of doses considered as "Expired."
- Site row, vaccine type, column N/O displays the number of allowed adjustments.
- Site row, vaccine type, column P displays the total net doses considered "Unaccounted for."
- Site row, vaccine type, column Q displays the total net percentages of doses considered **"Unaccounted for"** by calculating column P divided by E+F+I+J.
- Site row, vaccine type, column R displays the total cost of the **"Unaccounted for"** vaccine from the Vaccine Pricing Table.
- Site row, vaccine type, column S displays the absolute total of doses that are considered "Unaccounted for."
- Site row, vaccine type, column T displays the absolute percentages of doses considered "Unaccounted for" by calculating column S divided by E+F+I+J.
- Site row, vaccine type, column U displays the absolute cost of the **"Unaccounted for"** vaccine from the Vaccine Pricing Table.
- Site row, vaccine type, column V displays the **"Calculated Inventory on Hand"** by calculating columns E+F+G+I+J-W+O+P.
- Site row, vaccine type, column W displays total doses considered "Wasted, Spoiled and Expired."
- Site row, vaccine type, column X displays the total percentage of doses considered **"Wasted, Spoiled and Expired"** by calculating columns K+L+M+E+I+J.
- Site row, vaccine type, column Y displays the total cost of the **"Wasted, Spoiled, and Expired"** vaccines according to the Vaccine Pricing Table.
