VFC Temperature Monitoring Frequently Asked Questions



Q. HOW DO I ENTER A NEW STORAGE UNIT?

- **A.** Record five days of in range temperatures manually on paper before storing vaccine in the unit or adding the unit to Florida SHOTS. Please keep this documentation for your records.
 - After five days of acceptable temperatures are recorded, change the identifier for the old unit in Florida SHOTS by adding "old" to the name (for example: 123456-refrigerator old).
 - Enter a "thru date" on this unit to remove it from service.
 - Add the new unit using the previous identifier that matched your continuous temperature monitoring device (123456-refrigerator).

Q. WHY DOES MY ORDER SAY "SUSPENDED MISSING TEMP READINGS"?

A. You can view your missing temperatures by clicking on **Suspended** – **Missing Temp** readings at the top of your order, or by clicking the blue "**Information**" button next to your open order on the "**Order Request**" page. The temperature file needs to be uploaded for the missing readings or contact the VFC office for instructions on how to proceed if a temperature file is not available.

Q. WHY DOES MY ORDER SAY "SUSPENDED UNCALIBRATED STORAGE UNITS"?

A. This means you have not entered your calibration certificates for your thermometers, or the certificates you entered have expired. View your **Calibration Log** to verify and make any necessary changes.

Q. DO I HAVE TO UPLOAD TEMPERATURES EVERY DAY?

A. No, however you must upload temperatures at least once every 7 days. We recommended that your office uploads temperatures twice a week to avoid any ordering interruptions.

Q. WHEN I REVIEW MY UPLOADED TEMPERATURE FILE, I SEE EXCURSIONS. WHAT SHOULD I DO?

A. This means you have temperatures that are out of the acceptable range. Contact the VFC office **immediately** (phone: 1-877-888-7468, option 1 or email: **floridavfc@flhealth.gov**) to report the excursion(s) and to receive further instructions.

Q. WHAT DO WE DO IF WE DON'T HAVE TEMPERATURES RECORDED FOR A CERTAIN TIME PERIOD?

A. The continuous temperature monitoring device records temperatures even when the office is closed so this should not happen. If by chance your thermometer malfunctions, you will need to email the VFC office for instructions (floridavfc@FLhealth.gov).

Q. WHY DON'T I HAVE THE "BROWSE" BUTTON TO UPLOAD MY TEMPERATURE FILES?

A. After you enter your continuous temperature monitoring device, you must contact the VFC office or your Area Immunization Consultant to enable your "**Import Format**."

Q. WHY IS MY UPLOADED TEMPERATURE FILE "BLOCKED BECAUSE OF CONTENT ERRORS"?

A. This error can mean a few things. If you have a LogTag brand continuous temperature monitoring device, click "**View File**" to ensure your LogTag ID and your Identifier in Florida SHOTS match exactly. Second, does your file contain 21 header rows? If it does not, you will need to, "Include Summary" in the "Customize" tab for the csv file in your LogTag Analyzer software.
